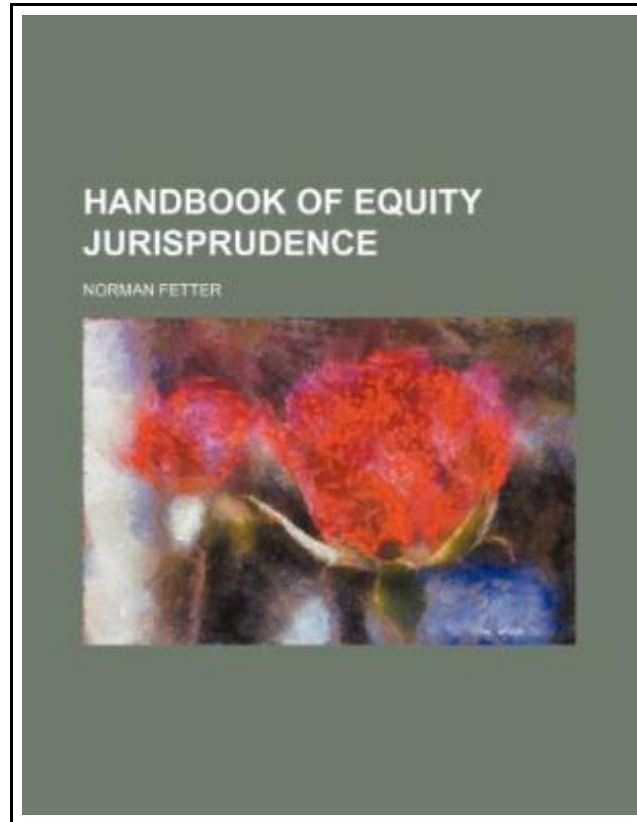

It was therefore at one time held in England that, on a voluntary conveyance to a stranger, a trust would result to the grantor when no intention appeared to confer a beneficial interest on the grantee.¹ This doctrine, however, never applied to conveyances to a wife or child, but an intention to make an advancement was presumed, and the wife or child took beneficially.¹²⁸ Under the system of conveyances in force in the United States, where land is conveyed to the use of the grantee, no use can, of course, result to the grantor, though the conveyance is voluntary;¹³⁹ and especially is this true of deeds containing covenants of warranty, which estop the grantor from claiming any legal or beneficial interest in the estate.¹³⁰ 3.
